In 2021 the Port Angeles Fine Arts Center was proud to carry our vision of inspiring the artist in every person forward. Through our programs we connected 3,800 people to the arts and supported more than 150 artists in exhibiting and selling their work through our gallery, gift store, Wintertide Maker's Market, and Art Park . We additionally, welcomed more than 25,000 visits to Webster's Woods Sculpture Park. Our 2021 programming included special evening community conversations, 4 gallery receptions, 4 gallery exhibitions, 2 outdoor exhibitions, 11 youth, family and adult workshops , youth education programming for nearly 1000 students per month-long maker's market, and 3 outdoor art festivals. A few highlights of our 2021 programming include rekindling our Summertime Solstice Festival, featuring open-air art installations, hands-on art activities, live poetry, and music performances for more than 500 community members. Additionally, we were proud to fill a significant need for youth arts enrichment with two weeks of Nature Art Summer Camp for 50 students, class room education with more than 600 students, and free field trips to our campus for over 250 students. Finally, we started a new tradition of igniting community hope and holiday joy with our 1st annual Wintertide Festival of Lights, lantern parade, and enhanced light experience in December 2021.
